RESOLUTION DECLARING NECESSITY OF BOND ISSUE, AND SUBMIT THE QUESTION OF SUCH ISSUE TO THE ELECTORS – On a motion by Wiley, seconded by Langsdon, the Board approved a Resolution Declaring Necessity Of Bond Issue. The bond issue will be in the amount of \$25,750,000, at an estimated interest rate of 4.75%, for a period not to exceed 28 years.

RESOLUTION DECLARING INTENT TO PROCEED WITH THE ISSUE OF BONDS AND CERTIFYING SAME TO THE BOARD OF ELECTIONS – On a motion by Gottschalk, seconded by Tobin, the Board approved a Resolution Declaring Intent to Proceed with the Issue of Bonds. The bond issue will be in the amount of \$25,750,000, at an estimated interest rate of 4.75%, for a period not to exceed 28 years. The County Auditor certified the millage at 6.9 mills or sixty-nine (\$0.69) cents for each \$100 dollars of tax valuation.
